Before lighting any burn, the permit holder must call the phone number provided 24 hours before the burn so the Waverly Fire Chief can notify the proper authorities. Failure to call could result in fines and/or penalties. All rules and regulations set forth by the State Fire Marshal of the State of Nebraska will apply.

Burning within the Waverly City Limits is forbidden per regulation 91.02 of the City of Waverly Municipal Code. The purpose of this permit is to allow for the clearing of land while removing natural, untreated lumber, trees, grass or vegetation. The Waverly Fire Chief and/or any member of the Waverly Fire Department have the ability to deny or terminate any burn permit. The burning of hazardous materials is prohibited, to include but not limited to herbage, salvage materials, petroleum products, solvents, treated lumber, wood paneling, particle board, rubber products, plastics, asphaltic products, tar products, shingles, asphaltic sidings, chemicals, pesticides or their containers, fertilizers, tires, oils, fuels, asbestos, or appliances.

Burning of buildings, structures, homes, barns, sheds, and dwellings is not allowed with this permit. Burning may not be conducted when wind speed is above 10 miles per hour. Burning which permits smoke to obscure any public roadway is prohibited. **While burning is in progress, adult supervision must be present at the burn sight. The supervisor must stay with the fire until it is fully extinguished.** Liquid petroleum products may not be used to accelerate or sustain the fire.            (Please initial here.)

All fires must be a minimum of 100 feet from all buildings and/or structures, tall grass, trees, or other flammable objects that aren't intended to burn. The permit holder is responsible for the fire. Should the fire burn out of control the permit holder will contact 911, and report the burn permit as "out of control". The permit holder could be held responsible for any damages or expenses incurred. Any questions should be directed in person at the fire station or by calling the Waverly Fire Department Monday nights between the hours of 7:00pm and 8:00pm, 402-786-3055. In case of an emergency call 911. These guidelines, ordinances, codes and inspections are intended to promote safety, avoid illegal burning and protect property. In the event that the fire comes out of control, the applicant and/or supervisor of the permit may be responsible for damages.
