ACKNOWLEDGMENT AND ASSUMPTION OF RISK

The above-listed player, coach, or official ("Participant") desires to participate in activities ("Activities") organized by the City of Waverly, Nebraska ("City") that, at times, may occur on property owned by the City and may, at times, utilize equipment and materials owned by the City. Inherent in the Participant's voluntary participation in and/or presence at such Activities are certain risks, dangers and hazards including, but not limited to: (a) strenuous and demanding physical exertion, strenuous cardiovascular workouts, rapid movements, exertion and tension on various muscle groups which may cause serious injury to virtually all bones, joints, ligaments, muscles, tendons and other aspects of the Participant's body or the Participant's general health and wellbeing; (b) concussion or other related head injuries including but not limited to closed head injury or blunt head trauma; (c) exposure to contaminants, contagions, viruses or pathogens; (d) exposure to extreme conditions and circumstances; and/or (e) contact with other participants, officials, administrators, spectators, or other natural or man-made objects, dangers arising from adverse weather conditions, imperfect field of play conditions, equipment failure or malfunction, inadequate safety measures and participants of varying skill levels. The Activities have foreseeable and unforeseeable inherent risks, hazards and dangers that no amount of care, caution or expertise can eliminate, including without limitation, the potential for serious bodily injury, sickness, disease, permanent disability, paralysis, and loss of life. The person signing below voluntarily assumes these risks because s/he chooses or elects to do so.

RELEASE AND INDEMNITY AGREEMENT AND COVENANT NOT TO SUE

In consideration of the Participant being allowed to participate in the Activities and to be present on City property relating to such Activities, the Participant or the parent(s) or legal guardian (if Participant is a Minor), on his or her own behalf and on behalf of any Minor Participant, agree as follows:

1. RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the City of Waverly, Nebraska, its elected officials, officers, directors, agents or employees (each a "Releasee" and collectively referred to as "the Releasees") from any and all liability to the Participant (or Participant's personal representatives, assigns, heirs, parents, legal guardians, siblings, children or dependents) on account of injury, illness, disease, or death occurring as a result of entering the property of the City, participating in or viewing any Activities, or other use of public facilities on the property of the City, whether such injury, sickness, disease, condition, or death is caused by the negligence or other wrongful conduct of one or more of the Releasees or any other participants, spectators or other individuals present at the Activities, or whether liability for such injury, sickness, disease, condition, or death is assigned to one or more of the Releasees as a matter of strict liability or any other legal doctrine.
2. AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES and each of them from any liability, damage or loss (including, but not limited to, attorneys' fees and other defense costs) one or more of them may suffer or incur arising out of or related to the Participant's or any of the undersigned's participation in and/or entry onto the property of the City in connection with any Activities, whether such claim is based on one or more of the Releasees' negligence, breach of contract or warranty, strict liability or other legal theory. The undersigned COVENANTS not to sue any Releasee related to injury, disease, loss, illness or death related to Participant's participation in any Activities or presence on City property relating to any such Activities.
3. THE PERSON SIGNING BELOW AGREE(S) that in the event any portion of this document is held to be invalid, the balance shall, notwithstanding, continue in full legal force and effect to the greatest extent possible under applicable law. The parents or guardian of the Participant agree that by signing below they are in addition to binding themselves and binding any minor Participant on whose behalf they have signed, to the maximum extent permitted by applicable law to this Agreement in full.
